

SEK 60m rights issue announced, o/w SEK 30m guaranteed

On 2 May, the company announced a rights issue, subject to shareholder approval at its 5 June AGM. Initial gross proceeds from the full rights issue would amount to nearly SEK 60m; 50.1% have been guaranteed by investors and management. Terms: Existing shareholders receive 7 unit rights for each existing share; 6 unit rights entitle to the subscription of 1 Unit in the Rights Issue at a price of SEK 1. Up to 59,972,451 Units can be issued. Each Unit comprises one share plus one free TO10 series warrant for one share exercisable in November/December plus one free TO11 series warrant exercisable in the fall of 2025. In conjunction with the recently announced SEK 22.5m dividend from the associated company AdaptVac, ExpreS2ion Biotech is set to receive gross cash inflows over SEK 50m, and possibly over SEK 80m, this year. Proceeds from the rights issue are intended to be used for the funding of initial clinical work on the breast cancer vaccine candidate ESB2-C001 as well as the early stage pipeline. Buy, PT SEK 9.
